Dear Mr. Beasley:

By this letter, the Commission staff requests that Tampa Electric Company (TECO or utility) provide responses to the following data requests at the telephonic informal meeting on September 25, 2012, at 10:00 AM.

1. Have you rejected PRECO's suggestion that TECO serve the entire area, and pay PRECO 50% of the base revenues, as stated in Mosaic's Complaint, in Paragraph 18? Please explain.
2. Have you rejected PRECO's suggestion that PRECO serve the Clay Settling Area, and that TECO serve the Mining Unit 20 Area, as stated in Mosaic's Complaint, Paragraph 19? Please explain.
3. Does the territorial agreement between TECO and PRECO allow a temporary variance to allow Mosaic to be served by TECO, but also cross into PRECO's territory? Please explain.


