# FLORIDA CITY GAS PRELIMINARY STATEMENT OF ISSUES AND POSITIONS

Florida City Gas submits this preliminary statement of issues and positions:

<u>Issue 1:</u> What are the final purchased gas adjustment true-up amounts for the period January 2011 through December 2011?

Florida City Gas: An over-recovery of \$1,905,623.

<u>Issue 2:</u> What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2012 through December 2012?

Florida City Gas: An under-recovery of \$2,194,043.

- <u>Issue 3:</u> What are the total purchased gas adjustment true-up amounts to be collected during the period January 2013 through December 2013?
- Florida City Gas: An under-recovery of \$288,420 for a true-up refund factor of 0.688 cents per therm.
- <u>Issue 4:</u> What are the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2013 through December 2013?
- <u>Florida City Gas:</u> Based on the winter months of October through March the appropriate (cap) factors are, 76.009 cents per therm (before the regulatory assessment fee) or 76.392 cents per therm (with the regulatory assessment fee).

<u>Issue 5:</u> What should be the effective date of the new purchased gas adjustment charge for billing purposes?
