SUMMARY: The rule requires gas utilities to respond to Commission staff inquiries within 15 days. The rule would be repealed.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE **RATIFICATION:**
