BUDGET PREPAY, INC.'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

Budget Prepay, Inc. ("Budget"), pursuant to rule 25-22.006, Florida Administrative Code, requests confidential classification for certain information contained in one document attached to the "Notice of Commencement of Collection Action" filed by BellSouth Telecommunications, LLC d/b/a AT&T Florida ("AT&T") on October 19, 2012 in the above-styled matter. As grounds therefor, Budget states:

1. On August 28, 2012, Budget filed a complaint with this Commission on August 28, 2011 to resolve a billing dispute with AT&T.

2. On September 17, 2012, AT&T answered Budget's complaint and asserted a counterclaim.

3. On October 8, 2012, Budget moved to dismiss AT&T's counterclaim for failing to meet a condition precedent to pursuing a claim, namely, failing to pursue dispute resolution as required by the parties' interconnection agreement.

3. Attached to AT&T's Notice of Commencement of Collection Action was a four page letter from AT&T to Budget dated October 19, 2012 for which AT&T provided the Commission with Notice of Intent to Request Specified Confidential Classification. AT&T indicated that Budget would be responsible for seeking confidential classification for any information it claimed as confidential. Accordingly, Budget is now seeking confidential protection for certain information as datailed herein

as detailed herein.

4. Section 364.183(3), Florida Statutes, provides that:

The term "proprietary confidential business information" means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public.

Section 364.183(3)(e), Florida Statutes, provides that "proprietary confidential business information" includes:

Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information.

5. Budget has reviewed the document AT&T attached to its Notice of Commencement of Collection Action and seeks confidential classification for only a portion of the document – information which reflects the amount of money involved in the billing dispute and a chart which reveals the monthly billing sums. The information for which Budget requests confidential classification is the following:

- Information regarding Budget's business activity in Florida as reflected in a monthly billing chart on page 4 of the confidential document and information regarding the billing amounts in dispute;
- Information regarding billing information contained on lines 2 and 12 on page 1 of the letter, information found on lines 4, 6, 8 and information contained within footnote 2 on page 2 of the letter.

This information falls squarely within the types of information for which confidential classification is appropriate. This information, if made public, could provide other competing telecommunications companies with useful information about Budget's activities in Florida that could be harmful to and impair Budget's competitive interests. This information is sensitive, confidential business information that should be protected as it falls within the clear scope of the statutory definition of "proprietary confidential business information".

6. Exhibit A to this request is one copy of the confidential information with such information highlighted in yellow. Exhibit A, which is filed under seal,

should be treated as confidential pending a ruling on this request. Exhibit B is two redacted copies of the information which may be made available for public review and inspection.

7. The designated information for which confidential classification is sought is intended to be and is treated by Budget as confidential.

WHEREFORE, Budget respectfully requests that the highlighted information on Attachment A be accorded confidential classification.

Re: Notice of Suspension and Discontinuance - Florida Resale Accounts

Dear Mr. Hyde:

AT&T Florida's records indicate that, as of September 30, 2012, Budget Prepay, Inc. ("Budget") has a past due balance of 'on Budget's Florida resale accounts, as shown on Attachment "A".

Under the terms of the parties' Interconnection Agreement (the "ICA"), Budget is required to pay AT&T Florida for "all services billed" "on or before the next bill date." ICA, Attachment 7, §§ 1.2.2, 1.3. The only exception for timely payment of all billed charges by Budget is "as provided in section 2," which is entitled "Billing Disputes." While Section 2.2 of the ICA allows Budget to withhold disputed amounts until the billing dispute is resolved, it narrowly defines a "billing dispute" as "a reported dispute of a specific amount of money actually billed by either party." (emphasis added).

According to AT&T Florida's records Rudget's open "billing disputes" (as that term is defined in the ICA) total no more than ; The remaining purported disputes do not relate in any way to an "amount of money actually billed" by AT&T Florida. Rather, Budget is Improperly withholding payments based on its claim for credits under certain long-distance promotional offerings by BellSouth Long Distance, Inc. (the "LD Claims"). Those LD Claims are not "billing disputes," as that term is defined in the ICA. At best, they are claims for damages; and the ICA unambiguously provides that "[c]laims by the billed party for damages of any kind will not be considered a billing dispute for purposes of this Section." ICA, Attachment 7, § 2.2.

Nothing in the ICA allows Budget to engage in self-help by withholding payment of validly billed, undisputed charges based on any claims for amounts or damages Budget contends AT&T Florida or any other entity owes it.

For the foregoing reasons, the LD Claims must be disregarded for the purposes of determining the undisputed amount due from Budget to AT&T Florida for resale services. After removing the disputes based on the LD Claims, AT&T Florida's records indicate that, at most, Budget has submitted a total of in disputes that can be considered, for the limited purposes of this letter, to be "billing usputes" under Section 2 of Attachment 7 to the ICA.¹ Thus, Budget has an undisputed past due balance of as of September 30, 2012.

Accordingly, pursuant to Section 1.7.2 of Attachment 7 to the ICA, AT&T Florida demands that Budget pay AT&T Florida (the "Undisputed Past Due Amount") within fifteen (15) days of the date of this nonce. In Budget fails or refuses to pay the Undisputed Past Due Amount by that date (i.e., November 5, 2012), AT&T Florida will refuse additional applications for service, pending orders for service will not be completed, and access to ordering systems will be suspended, in accordance with Section 1.7.2.

In addition, if Budget does not pay the Undisputed Past Due Amount and all other amounts not in dispute that come past due by the thirtieth (30th) day following the date of this notice (i.e., November 19, 2012), AT&T Florida will discontinue the provision of existing services to Budget, in accordance with Section 1.7.2.

Without waiving the foregoing, and given the pendency of Docket No. 120231-TP before the Florida Public Service Commission, AT&T Florida will voluntarily delay suspension and disconnection until at least the close of business on November 27, 2012, to give Budget an opportunity to request that the Florida Public Service Commission address this issue at its November 27, 2012 Agenda Conference. Absent payment or a Commission ruling directing otherwise, AT&T will suspend service no earlier than close of business on November 27, 2012.

¹ AT&T Florida does not agree that the remaining disputes are valid or correct. AT&T Florida merely recognizes that the other disputes submitted by Budget may be of the type that are considered to be "billing disputes" for the purposes of determining the amount of undisputed past due charges due from Budget to AT&T Florida for resale services at this time. AT&T Florida does not waive, and expressly preserves, its right to pursue collection of all monies due, or that may come due, from Budget, including but not limited to the collection of all monies withheld as a result of those other disputes.

This amount is calculated by reducing the current past due balance of the by the amount of billing disputes which are unrelated to the LD Claims and which may relate to amounts billed by AT&T Florida to Budget for resale services.
