

**SECTION 63.71 APPLICATION**

XO Communications, LLC (“XO” or “Applicant”) hereby seeks authorization, pursuant to Section 214(a) of the Communications Act of 1934, as amended (the “Act”), 47 U.S.C. § 214, and Section 63.71 of the Commission’s rules, 47 C.F.R. § 63.71, to discontinue its provision of selected dial-up services (“Dial-Up Services”) to a limited number of customers. Specifically, XO is discontinuing the provision of the transmission component of the Dial-Up Services. The services to be discontinued currently are provided by XO’s operating subsidiary, XO Communications Services, LLC (“XOCS”). XO is a leading provider of local and long distance telecommunications services, interexchange access services, VoIP services, Internet access services and other information/enhanced services. XO is authorized by the Commission to provide both interstate and international telecommunications services. XOCS is authorized to provide intrastate telecommunications services in 49 states and the District of Columbia.<sup>1</sup>

The Applicant provides the following information pursuant to Section 63.71 of the Commission’s Rules:

1. Name and Address of Carrier: XO is located at 13865 Sunrise Valley Drive, Herndon, Virginia 20171-4661.

2. Date of Planned Service Discontinuance, Reduction or Impairment: The Applicant plans to discontinue the provision of its Dial-Up Services effective January 21, 2013. Applicant understands that this application will be automatically granted on the 31<sup>st</sup> day after public notice of filing unless the Commission notifies the Applicant to the contrary.

3. Points of Geographic Areas of Service Affected: XO proposes to discontinue the provision of its Dial-Up Services throughout its nationwide service territory.

4. Brief Description of Type of Service Affected: The XO Dial-Up Service offerings affected by this discontinuance are its Consumer Dial and Corporate Dial services. The Consumer Dial and Corporate Dial service offerings provide standalone dial up service in addition to e-mail service and, for Corporate Dial service, website services. XO operates as an internet service provider ("ISP") for these Dial-Up offerings, providing the transmission as well as the e-mail and web services. For each of the Dial-Up Services, XO will be discontinuing its provision of the transmission component of the service. For the Consumer Dial and Corporate Dial services, the information service component of the services will be migrated to a new platform.

XO is in the process of streamlining its product offerings. Accordingly, XO has decided to discontinue its Dial-Up Services to better focus on those services most requested by its customers. The proposed discontinuance of XO's Dial-Up Services will not harm the affected customers because there are other alternative dial-up service providers and technologically advanced services that perform essentially the same or better functions. Further, the affected

customers should easily be able to obtain alternative means to the transmission component from other ISPs as well as other telecommunications carriers.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers:

In accordance with Section 63.71(a), during the week ending November 30, 2012, XO provided written notice, by first class mail or e-mail to its affected subscribers. Many of XO's affected customers are long-time subscribers and have elected to have their monthly service charges paid automatically by credit card or debit from a bank account. XO does not mail paper invoices to these subscribers. Instead all communications are conducted by e-mail. Due to the longstanding nature of these accounts and the subscribers' preference for automated payments and e-mail correspondence, XO does not have current physical mailing addresses for a small number of these subscribers. Accordingly, those subscribers, for whom XOCS does not have physical mailing addresses, were notified by e-mail of the impending discontinuance of the Applicants' Dial-Up services. XO believes these e-mailed notices satisfy the requirements of Section 63.71(a) that customers be provided with written notice of a discontinuance. To the extent a waiver of the Section 63.71(a) written notice requirement is necessary, XO hereby respectfully requests such waiver. A sample copy of the notices to customers is attached hereto as Attachment A.

6. Whether the Carrier is Considered Dominant or Non-Dominant with Respect to the Service to Be Discontinued, Reduced or Impaired: Applicant is considered non-dominant with respect to the affected services.




