Pursuant to Section 364.33, Fla. Stat., AT&T Communications of the Southern States, LLC and AT&T Corp. hereby provide notice to the Florida Public Service Commission of the acquisition by AT&T Corp. of Certificate TA062. AT&T Corp. and AT&T Communications of the Southern States, LLC are wholly-owned subsidiaries of AT&T Inc.

Effective November 1, 2012, AT&T Communications of the Southern States, LLC was merged into AT&T Corp. with AT&T Corp. being the surviving entity. Pursuant to the merger, AT&T Corp. has acquired Certificate TA062. AT&T Corp. has assumed provision of the services provided by AT&T Communication of the Southern States, LLC. For regulatory purposes involving Certificate TA062, AT&T Corp. should be substituted for AT&T Communications of the Southern States, LLC.
