NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING CERTIFICATE OF AUTHORITY
TO PROVIDE LOCAL TELECOMMUNICATIONS SERVICE.

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Zayo Group, LLC (Zayo) applied for a Certificate of Authority to provide telecommunications service, pursuant to Section 364.335, Florida Statutes. Upon review of the application, it appears that Zayo has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant to Zayo Certificate of Authority No. 8836, which authorizes Zayo to provide telecommunications service throughout the State of Florida.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, Certificate of Authority holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Zayo for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Zayo from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Zayo's certificate. Therefore, Zayo shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, Florida Statutes.
