NOTICE OF VIOLATION OF FEDERAL LAW.....

RELIEF SOUGHT: To prevent interruption of service for improper/FRAUDULENT bills

COMPLAINT

TECO HAS UNLAWFULLY CHARGED COMPLAINANT IN VIOLATION OF THE U.S. BANKRUPTCY CODE by engaging in "collection" action on the bankruptcy estate after being duly notified of the Feb. 5, 2013 Chapt. 7 filing. They were notified the day of filing.(1)

On Feb. 11, 2013, WITH FULL KNOWLEDGE OF THE BANKRUPTCY FILING, TECO submitted a bill that violates Federal Law. (2)

The deposit bill for \$265.00 is a replacement for the unlawful COLLECTION from the bankruptcy estate and those funds should be reinstated as the customer's deposit. (3)

The date for interruption of service for lack of payment of a deposit should be RESCINDED.(4)

Thirty (30) days after the *conclusion* of the meeting of creditors.

Creditors May Not Take Certain Actions:

In most instances, the filing of the bankruptcy case automatically stays certain collection and other actions against the debtor and the debtor's property. Under certain circumstances, the stay may be limited to 30 days or not exist at all, although the debtor can request the court to extend or impose a stay. If you attempt to collect a debt or take other action in violation of the Bankruptcy Code, you may be penalized. Consult a lawyer to determine your rights in this case.
