On behalf of Florida Power & Light Company ("FPL"), I am writing to request that your office include the enclosed document as part of the record that will be transmitted to the Florida Supreme Court in connection with the Office of Public Counsel's appeal in Supreme Court Case No. SC13-144. The enclosed document is a copy of an e-mail to your office dated March 16, 2012 from Charles Milsted, Associate State Director for the AARP, asking that the AARP be identified as an interested person in this docket, together with a reply e-mail from your office dated March 16, 2012 confirming that the AARP has been added as an interested person.
