We have determined eligibility for staff assistance in the above referenced case filed by LP Waterworks, Inc. (LP Waterworks or Utility). We find that the Utility is eligible for the staff assisted rate case (SARC) filing.

The staff engineer has determined the filing fee in this rate case is \$2,000. The fee is based on the capacity of the Utility's systems as provided by Section 367.145(2) of the Florida Statutes. The filing fees must be received by July 22, 2013, which is the official filing date for this rate case.
