MOTION FOR EXPEDITED HEARING OF JOINT MOTION
OF THE DEBTORS AND HERCULES TECHNOLOGY II, L.P. TO
(I) ENFORCE ASSET PURCHASE AGREEMENT BETWEEN DEBTORS
AND TNCI OPERATING COMPANY LLC, (II) ENFORCE ESCROW
AGREEMENT, (III) DIRECT THAT ESCROW AGENT BE DIRECTED
TO DISTRIBUTE INTERIM CLOSING PROCEEDS FROM ESCROW
AMOUNT TO HERCULES TECHNOLOGY II. L.P AND (IV) FOR RELATED RELIEF

COMES NOW UPH Holdings, Inc. ("UPH"), Pac-West Telecom, Inc. ("Pac-West"),

Tex-Link Communications, Inc. ("Tex-Link"), UniPoint Holdings, Inc. ("UniPoint

Holdings"), UniPoint Enhanced Services, Inc. ("UniPoint Enhanced"), UniPoint Services, Inc.

("UniPoint"), nWire, LLC ("nWire") and Peering Partners Communications, LLC ("Peering

Partners") (collectively the "Debtors"), and files this Motion for Expedited Hearing of the

Joint Motion of the Debtors and Hercules Technology II, L.P. to (i) Enforce Asset Purchase

Agreement Between Debtors and TNCI Operating Company, LLC, (ii) Enforce Escrow Agreement, (iii) Direct That Escrow Agent be Directed to Distribute Interim Closing Proceeds From Escrow Amount to Hercules Technology II, L.P. and (iv) for Related Relief ("Joint Motion") [Dckt. No. 580] and would show unto the Court as follows:

- 1. The Debtors and Hercules seek an Order of the Court enforcing the Asset Purchase Agreement and Escrow Agreement and directing that the Escrow Agent distribute the applicable portion of the Escrow Amount to Hercules at the first and subsequent Interim Closings and the Final Closing.
- 2. General unsecured creditors will be harmed every day that any payment to Hercules is delayed. If Hercules does not receive its scheduled payments from the Escrow Amount, interest on Hercules' secured claim will continue to accrue at the rate of approximately \$1,106.00/day. This will prejudice unsecured creditors unfairly. The quicker Hercules's secured claim is reduced and satisfied, the less interest expense will accrue and the greater the ultimate recovery to priority and general unsecured creditors will be. In addition, a hearing is already set on approval of the Debtors' Disclosure Statement [Dckt. No. 515], and resolution of the issues related to Joint Motion prior to such hearing promotes efficient administration of these estates.
- The undersigned counsel has conferred with counsel for TNCI, and they are not opposed to request of an expedited setting of the Joint Motion.
 - 4. The Debtors believe that the hearing should take approximately one (1) hour.
- The Debtors request that this hearing be held either November 20 or November 21, 2013.

WHEREFORE, PREMISES CONSIDERED the Debtors request that the Joint Motion be set on either date requested herein on this Court's docket.
