Attached please find the original and five copies of the response of Forest Utilities, Inc. to the three data requests contained in the November 18, 2013 letter of Suzanne Brownless.

- 1. According to the Settlement Agreement between Forest Utilities (Forest) and Jamaica Bay West, the rate Forest charges Jamaica Bay West shall not exceed Lee County's prevailing multi-family metered rates.
 - a) What is the size of the master meter that serves Jamaica Bay West?
 - 2-10" turbine meters will serve Jamaica Bay West.
 - b) What is the multi-family rate currently being billed to Jamaica Bay West by Lee County? How does it compare to the rate Jamaica Bay West would be billed by Forest?

LCU's current monthly multi-family rate for 2013 is: \$13.01 base charge per unit plus + an administrative charge of \$3.28 per unit + \$5.59 per 1,000 gals of water usage.

Per Forest's August 27, 2013 letter to Marshall Willis, Jamaica Bay will be billed in accordance with Forest's existing Twenty-Second Revised Sheet No. 16.0 (attached) as a general service master metered customer.

c) If Forest rates do exceed Lee County's rates, how will Forest treat the revenue deficiency attributed to a capped rate for Jamaica Bay West in a subsequent rate proceeding?

The rates of Forest have never exceeded, and Forest does not anticipate that its rate will ever exceed, the Lee County rate. In the unlikely and unforeseeable event that Lee County's rates exceeded the applicable rate of Forest, treatment of any revenue "deficiency" would be coordinated with PSC staff based on all of the facts and circumstances existent at that time.
