By Order No. PSC-13-0140-PAA-WU, issued March 25, 2013, the Utility was required to provide Commission staff with a report within six months of this order, detailing its efforts in obtaining USDA funding to replace the water distribution system and obtain the appropriate DEP permitting. By e-mail dated September 25, 2013, the Utility provided the required USDA status report. Staff has reviewed the report and discussed the project status with the Utility. In reference to Docket No. 120183-SU letter dated June 25, 2013; Order No. 2, the following steps have been taken.

- The USDA has been requested by Mr. Sterling Carroll of the Florida Rural Water Association, to extend the loan/grant application to replace the water distribution system at Three Lakes Park.
- 2.) The system is being redesigned at this time due to the residents of Sunset View subdivision on Lakeside Lane and Canal Streets having signed a contract with the City of Tavares to supply municipal water and sewer. Construction has been delayed to January of 2014.
- 3.) These delays have made it necessary for Three Lakes Park to put their plans on hold until the municipal construction is completed.
- 4.) Waiting for all customers of TLP Water, Inc. to be placed on municipal water will leave the Three Lakes (Sr.)Park residents eligible for a loan/grant from the USDA.
- 5.) The revised application to USDA will be submitted next week by Mr. Sterling Carroll of the Florida Rural Water Association.
