Dear Mr. Willis,

I am writing on behalf of Forest Utilities, Inc. ("Forest") to request the withdrawal of Seventh Revised Sheet No. 17.1 (attached) from Forest's existing wastewater tariff effective immediately upon conveyance of the Jamaica Bay Manufactured Home Community ("Jamaica Bay") internal wastewater collection system to Forest which is anticipated to occur in the next 12 months. At the time of such conveyance, this tariff sheet will no longer be applicable to Jamaica Bay or to any other customer of Forest. After the conveyance of that system, Jamaica Bay will be billed in accordance with Forest's existing Twenty Second Revised Sheet No. 16.0 (attached) as a general service master metered customer.

The only customer affected by this change, Jamaica Bay, has agreed that after conveyance of the system to Forest, as contemplated by an agreement executed between the parties in settlement of a circuit court case, that service to Jamaica Bay will be rendered pursuant to and consistent with the provisions of Twenty Second Revised Sheet No. 16.0 in Forest's wastewater tariff.

We are therefore attaching Eighth Revised Sheet No. 17.1 to show that sheet as being "Held for Future Use". We request the Commission recognize the change in this tariff sheet and make such change effective immediately upon the conveyance of the internal Jamaica Bay wastewater collection system.

For the Commission's information, we have attached an estimate of the expected additional revenues which will result from this change in character of the Jamaica Bay Manufactured Home Community (from bulk customer to multifamily general service customer). This change is projected to produce an additional \$119,699 in revenue and an additional \$100,720 in expenses with a net effect on utility income of approximately \$18,949. Forest will still be in a loss position after this change is made. While this information is not required under the Commission's rules for withdrawal of tariffs (See Rule 25-9.045, Florida Administrative Code), we felt that this information would be helpful to staff in review of this request.

Should you have any questions in this regard, please let me know. Otherwise, please approve the requested change in tariff sheet 17.1 and approve Eighth Revised Sheet No. 17.1 attached hereto with an effective date of the date upon which conveyance of the internal collection system, as referenced hereinabove, is completed.
