3 Toni Earnhart with Commission staff.

4 Item 5 is staff's recommendation that the
5 Commission grant Broadstar, LLC d/b/a PrimeCast's
6 cancellation of its local exchange telecommunications
7 company certificates, service schedules, and remove the
8 company's name from the Master Commission Directory
9 effective October 15th, 2013, due to Chapter 7
10 bankruptcy status, and direct the Division of
11 Administration and Information Technology Services to
12 request permission from the Florida Department of
13 Financial Services to write off any unpaid regulatory
14 assessment fees, including statutory late payment
15 charges, instead of requesting collection services, and
16 require the company to immediately cease and desist
17 providing the local exchange services in Florida.

18 There is no one here representing Broadstar,
19 LLC, d/b/a PrimeCast. Staff is prepared to answer any
20 questions that you may have.


