Please place this memorandum in the main docket file for Docket Nos. 130203-EM, 130199-EI, 130200-EI, 130201-EI, 130202-EI, 130204-EM, and 130205-EI and distribute it to all parties of record. This memorandum contains the substance of a communication that passed between myself and Susan Glickman with the Southern Alliance for Clean Energy when I ran into her in the Capitol on March 24, 2014.

Ms. Glickman expressed her opinion that not enough is being accomplished in energy conservation. She said we're at .1% conservation, and the aspirational goals set by the Commission in the last goal-setting proceeding had the potential to achieve .35% conservation.

I asked Ms. Glickman what she is suggesting. She referred me to the 2009 report on which the current goals are based. I also asked why SACE is opposed to nuclear power plants in light of the fact that they don't emit pollutants and greenhouse gases. She said more could be accomplished through conservation than through nuclear power.

To ensure compliance with 350.042, F.S., I am providing this documentation for the docket file.
