2 **CHAIRMAN GRAHAM:** So we are going down to
3 Item Number 9.

4 **MR. HILL:** Good morning, Commissioners. I'm
5 Adam Hill with Commission staff.

6 Item 9 concerns Central Sumter Utility
7 Company's application for amendment of water and
8 wastewater certificates in Lake County. The most
9 recent Commission action was to approve an amendment in
10 2013 that increased the utility's customer base to
11 approximately 3,334 water and 3,177 wastewater
12 customers, which makes the utility a Class B water and
13 wastewater utility. The proposed amendment would serve
14 an additional 2,041 customers in the new territory
15 within Lake County.

16 Staff recommends that the Commission should
17 grant the certificates -- oops, pardon me, the
18 amendment. Staff is prepared to answer any questions
19 the Commission may have.
