This letter is in reference to SmallCells Tower Company, LLC's (SmallCells) January 7, 2014, Application for Authority to Provide Telecommunications Service. As you are aware, staff considers SmallCells' application deficient as it relates to the financial capability requirement. Specifically, **Section 17.(c)** of the application states that applicants must submit the following:

Financial Capability: applicant's audited financial statements for the most recent three (3) years. If the applicant does not have audited financial statements, it shall so be stated. Unaudited financial statements should be signed by the applicant's chief executive officer and chief financial officer affirming that the financial statements are true and correct and should include:

- 1. the balance sheet,**
- 2. income statement, and**
- 3. statement of retained earnings.**

Consistent with the requirement presented above, we request that SmallCells submit the applicable information by June 5, 2014. If we do not receive the information by June 5, 2014, staff will consider SmallCells' application incomplete and proceed to close the docket.

Your company may avail itself of the statutory confidential provisions of Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, if it believes it is necessary to comply with this data request.
