Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light requests confidential classification of highlighted information in its responses to Interrogatories 45 and 55, from FPL's Amended Responses to Staff's 2<sup>nd</sup> Set Of Interrogatories (Nos. 12-94), filed on July 31, 2014.
