Docket No. 140038-SU – Application for transfer of majority organizational control of Crooked Lake Park Sewerage Co. in Polk County, and for name change on Certificate No. 517-S to Glenbrook Properties, LLC, a Florida limited liability company.

Issue 1: Should the application for transfer of majority organizational control of Crooked Lake Park Sewerage Company in Polk County and name change on Certificate No. 517-S to Glenbrook Properties, LLC be approved?

Recommendation: Yes. The transfer and name change on Certificate No. 517-S to Glenbrook Properties, LLC, is in the public interest and should be approved effective the date of the Commission vote. The resultant order should serve as the wastewater certificate, with the territory described in Attachment A of staff's memorandum dated December 4, 2014, for Glenbrook Properties, LLC, a Florida limited liability company. The existing rates and charges should remain in effect until a change is authorized by the Commission in a subsequent proceeding. The tariffs reflecting the transfer and name change should be effective for services rendered or connections made on or after the stamped approval date on the tariffs, pursuant to Rule 25-30.475, Florida Administrative Code (F.A.C.).
