AGREEMENT TO PROVIDE TELECOMMUNICATIONS RELAY SERVICE (TRS) TO FLORIDA

First Amendment to Agreement

This Amendment (Amendment) is made pursuant to Section A.24 of the Request for Proposals by the Florida Public Service Commission (Commission) and Sprint Communications Co. L.P., (Sprint), parties to the Agreement to Provide Telecommunications Relay Service to Florida (Agreement) as more specifically set forth below.

Sprint and the Commission agree to amend the Agreement as follows:

Section 2. entitled "Contract Term" of the Agreement and Section B.3. entitled "Term of Contract" of the Request for Proposals state that service under the Agreement shall begin on June 1, 2015. The Commission and Sprint hereby amend the service start date from June 1, 2015 to March 1, 2015.

Section 2. entitled "Contract Term" of the Agreement and Section B.3. entitled "Term of Contract" of the Request for Proposals also state that the term of the Agreement is an initial three year period allowing this term to be extended for up to four additional one year periods. The date contained in Section 2 of the Agreement and Section B.3., of the Request for Proposals upon which Sprint shall notify the Commission of its desire to extend service is hereby amended from June 1 to March 1. The parties hereby amend the example in Section B.3. of the Request for Proposals to state that the Agreement service period is due to expire on February 28, 2018, not May 31, 2018. The parties also amend Section B.3. of the Request for Proposals to state that Sprint shall notify the Commission by March 1, 2017, not June 1, 2017, that it desires a one year extension of service.

This Amendment makes only the stated changes to the Agreement. No change other than what is stated herein is made to the Agreement either implicitly or implied. Except as set forth in this Amendment, all other terms and conditions of the Agreement are unaffected and shall continue in full force and effect in accordance with the terms of the Agreement.

The Commission and Sprint acknowledge that this Amendment is a public record, is available to the public for inspection, and may be posted on a web site by the State of Florida.
