On January 16, 2015, Peninsula Pipeline Company, Inc., (Peninsula) filed a request for confidential classification for Document No. 00338-15. This document is Exhibit A to a firm transportation service agreement between Peninsula and the Florida Division of Chesapeake Utilities Corporation (Chesapeake). The information in the document for which Peninsula seeks confidential treatment relates to the maximum daily transportation quantity (MDTQ), the monthly reservation charge, the maximum hourly transportation percentage (MHTP), and the unauthorized use charge. Staff has reviewed the document and concurs with Peninsula that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm Peninsula's competitive business operations.

Therefore, staff recommends that Peninsula's request for confidential classification of Document No. 00338-15 be approved.
