Pursuant to 54.312 (b)(3) as amended by an FCC Order on Reconsideration released July 16, 2013 (FCC 13-97) attached for your information is a copy of a cover letter dated January 16, 2015 from AT&T notifying the FCC that AT&T is modifying its broadband deployment plans for meeting its CAF Phase I – incremental, Round 2 commitment. A list of additional census blocks in Florida not identified in AT&T's initial acceptance of CAF Phase I support is also included for your information. Dear Ms. Dortch:

AT&T Inc. (AT&T), on behalf of its incumbent local exchange carriers (ILECs), accepted 2013 Connect America Fund (CAF) Phase I incremental support on August 20, 2013. At the time of acceptance, AT&T submitted an initial list of identified locations to which it planned to deploy broadband to meet its CAF Phase I service obligations.

In the intervening months, AT&T has modified its broadband deployment plans. As a result, pursuant to the requirements of 54.312(b)(3), we are now submitting a list of 7,931 census blocks not initially identified at the time of election. We will submit a list of census blocks that are no longer in our CAF Phase I incremental deployment plan in a subsequent filing as required. However, we note that while our initial list included locations in 12 states, our final deployment plan is now limited to nine states (AL, FL, GA, KY, LA, MS, NC, SC, and TN).

A copy of this notice is being sent to the Bureau, the Administrator and relevant state commissions. (There are no tribal locations in this deployment plan and thus no affected tribal governments.) Please do not hesitate to contact me should you have any questions regarding this filing.
