

Dear Oak Bend Residents:

In 2011, OB Utility Systems, L.L.C., (the "Utility"), submitted an application to the Florida Public Service Commission (the "Commission") for certificates to provide water and wastewater service as a utility regulated by the Commission. On January 13, 2012, the Commission issued a final order that approved the Utility's application for certificates to operate and that set the initial rates to be charged. The rates established by the Commission are shown in the attached customer notice.

In the time since the final order was issued in 2012, the Utility has installed individual meters adjacent to each rental lot so that water usage can be measured at that location. In addition, previously, the cost for these services has been included in the lot rental fee charged. Recently you received a 90 day notice including an adjustment in the lot rental fee that decreases the current lot rental fee as an offset for the regulated Utility rates that will be charged.

Beginning approximately February 1, 2015, the rates shown in the attached customer notice will go into effect and customers will begin receiving individualized invoices based on the amount of water used. For example, a residential customer with a 5/8" x 3/4" meter (which is the standard size for homeowners and home renters serviced by this Utility) will pay a monthly base facility charge of \$10.58 and a gallonage charge of \$2.77 per 1,000 gallons of water used. Wastewater charges will include a separate base facility charge and a gallonage charge for wastewater, which is also based on the gallons of water used, up to a maximum of 6,000 gallons. These rates, approved by the Commission, were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service.

This notice was prepared by the Utility and has been approved by the Commission Staff for distribution by the Utility to its customers. If you have any questions about your bill, please contact the Utility at 352-237-2136.

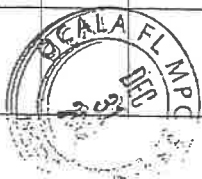


