5           **MR. GARL:** Thank you, Mr. Chairman. Good  
6 morning, Commissioners. I'm Steve Garl with Commission  
7 staff.

8           Item 6 is a Tampa Electric Company, TECO,  
9 request for approval of a revised tariff for  
10 lighting of streets and parking areas. TECO  
11 proposes closing existing high pressure sodium and  
12 metal halide tariffs to new customers, leaving light  
13 emitting diode, or LED, technology as the only  
14 option.

15           In addition, TECO wishes to expand its  
16 current LED tariff offerings with nine new fixtures.  
17 Staff's review of the cost information shows the  
18 revisions of the proposed tariffs are reasonable and  
19 appropriate. Staff recommends approval.

20           **CHAIRMAN GRAHAM:** Commissioners, any  
21 questions of staff on Item Number 6? Seeing none, I'll  
22 stand for a motion.

23           **COMMISSIONER EDGAR:** Mr. Chairman, I move  
24 approval on the staff recommendation.
