Dear Ms. Stauffer:

In Order No. PSC-14-0521-FOF-WS, the Commission established a methodology for determining the amount of the expense of Project Phoenix that should be included in the revenue requirement of Utilities Inc. subsidiaries, including the regulatory assets established in prior Commission Orders for most such subsidiaries. That methodology provides that "the total current number of total ERCs would be divided by the total company ERCs in place at the time Phoenix Project was implemented." In addition, it is appropriate to pro forma those additional ERC's known to connect subsequent to the test year. Attached is a schedule showing the change in ERCs.

Further, Order No. PSC-14-0521-FOF-WS allocated \$43,798 (\$10,950 annually) in rate case expense that should be included in the rate case expense in this Docket. Should you or the staff have any questions please do not hesitate to contact me.
