Good morning Bob, I see that there are three dockets on today's Agenda regarding bankruptcy cancellations. They are:

- 150095-TX – Tennessee Telephone Services, LLC d/b/a Freedom Communications USA, LLC - Company Code TX802
- 150096-TX – Terra Telecommunications Corp. – Company Code TX677
- 150097-TX - StarVox Communications, Inc. – Company Code TX946

I see in the staff recommendation for them, they stated that each bankruptcy case has been closed. We still have them listed as being **in bankruptcy**.
