## CITIZENS' DIRECTIONS TO CLERK OF THE FLORIDA PUBLIC SERVICE COMMISSION AND STATEMENT OF ACTS TO BE REVIEWED

Pursuant to Rule 9.200(a)(3), Florida Rules of Appellate Procedure, the Citizens of the State of Florida ("Citizens"), through the Office of Public Counsel ("OPC"), hereby direct the Clerk of the Florida Public Service Commission to include in the record described in Rule 9.220, Florida Rules of Appellate Procedure, the items identified herein.

Within these Directions, "OPC" or "Citizens" means the Office of Public Counsel; "FPL" refers to Florida Power & Light Company; "FIPUG" is the acronym for the Florida Industrial Power Users Group; and "FRF" means the Florida Retail Federation.

1. As stated in Citizens' Notice of Administrative Appeal in the above case, Citizens' appeal Order No. PSC-15-0284-FOF-EI ("Guidelines Order"). Order No. PSC-15-0284-FOF-EI is the Final Order Approving Modified Gas Reserve Guidelines resulting from FPL's June 25, 2014 Petition in Docket No. 140001-EI that carried over into Docket No. 150001-EI. Accordingly, unless otherwise specifically listed below, please exclude from the record on appeal all pleadings, orders, prefiled testimony, transcripts of hearings, exhibits, and all other documents in the docket file of Docket Nos. 140001-EI and 150001-EI that relate to and are associated with the petitions filed by Duke Energy Florida, Tampa Electric Company, Gulf Power Company, and Florida Public Utilities Company. It is the intent of these Directions to exclude all documents that relate solely to utilities other than FPL, and to include documents that relate only to FPL's June 25, 2014 Petition.

2. As a majority of the record for the Guidelines Order is already before the Supreme Court in consolidated cases SC15-95, SC15-113, SC15-115, and SC15-274 ("Consolidated Cases"), these instructions incorporate the Consolidated Index and Record On Appeal, Document No. 02966-15 filed May 19, 2015, attached hereto as exhibit A.

3. With respect to the pleadings, testimony, and exhibits relating to and associated with the petition for approval submitted by Florida Power & Light Company in Docket No. 140001-EI carried over into Docket No. 150001-EI, Citizens direct the Clerk to include in the record on appeal all documents in the consolidated index, Exhibit A, and the following additional portions of the docket file in Docket No. 150001-EI:
