**DUKE ENERGY FLORIDA, LLC'S SEVENTH REQUEST
FOR CONFIDENTIAL CLASSIFICATION**

Duke Energy Florida, LLC (“DEF” or the “Company”), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Seventh Request for Confidential Classification concerning portions of Florida Public Service Commission Staff-Generated Auditors’ Workpapers (the “Workpapers”). These documents contain confidential contractual, financial, vendor, and employee information, the disclosure of which would impair DEF’s competitive business interests. These documents meet the definition of proprietary confidential business information pursuant to section 366.093(3), F.S. The unredacted documents are being filed under seal with the Commission on a confidential basis to keep the competitive business information in those documents confidential.

BASIS FOR CONFIDENTIAL CLASSIFICATION

Section 366.093(3), F.S., provides that “any records received by the Commission which are shown and found by the Commission to be proprietary confidential business information shall be kept confidential and shall be exempt from [the Public Records Act].” § 366.093(1), F.S. Proprietary

confidential business information means information that is (i) intended to be and is treated as private, confidential information by the Company, (ii) because disclosure of the information would cause harm, (iii) either to the Company's customers or the Company's business operation, and (iv) the information has not been voluntarily disclosed to the public. § 366.093(3), F.S. Specifically, "information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms" is defined as proprietary confidential business information. § 366.093(3)(d), F.S. Additionally, section § 366.093(3)(e), F.S. defines "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information," as proprietary confidential business information.

DOCUMENTS AT ISSUE

Portions of the aforementioned documents should be afforded confidential classification for the reasons set forth in the Affidavit of Marcia Olivier filed in support of DEF's Request for Confidential Classification, attached hereto as Exhibit D, for the following reasons. Specifically, portions of these documents contain individual employee and contractor names coupled with amounts paid to each employee and contractor in wages and expenses (along with other related expenses such as material, equipment and subcontractor fees), as well as reimbursements for meals, travel, and lodging expenses. DEF maintains the confidentiality of such information to protect DEF's employees' and contractors' individual right to privacy, *see* art. I, sec. 23, Fla. Const.; § 366.093(3)(f), F.S., and to protect the Company's competitive business interests, *see* § 366.093(3)(e), F.S.; Affidavit of Marcia Olivier, ¶ 7. If DEF cannot protect its employees' and contractors' right to

privacy, it will be at a competitive disadvantage when seeking to hire and retain qualified employees and contractors. *See* § 366.093(3)(e), F.S.; Affidavit of Marcia Olivier, ¶ 7.

Also included in the auditors' Workpapers is information relating to parties purchasing DEF's CR3 nuclear unit assets. This information contains and includes sensitive business information, including pricing agreements, purchasers names, DEF employee names, and banking information, the disclosure of which would harm DEF's competitive business interests. Affidavit of Marcia Olivier at ¶ 5. In order to obtain competitive prices for these assets, such pricing terms, names and banking information must remain confidential. DEF has kept confidential and has not publicly disclosed the costs and provisions at issue here. Absent such measures, DEF would run the risk that sensitive business information regarding what it is willing to accept as payment for certain assets, would be made available to the public and, as a result, other potential purchasers of such assets could change their position in negotiations with DEF. Without DEF's measures to maintain the confidentiality of sensitive terms in these documents, the Company's efforts to obtain competitive disposition of the CR3 assets would be undermined. Affidavit of Olivier at ¶ 5. Accordingly, this information should be afforded confidential treatment by the Commission. *See* § 366.093(3)(d)(e)(f), F.S.

In addition, the Workpapers contain confidential contractual and financial information relating to CR3 security contracts and also include a contractor refund payment, the release of which would impair DEF's competitive business interests and ongoing negotiations with vendors. Affidavit of Olivier at ¶ 5. The disclosure of this information would compromise DEF's competitive business interests and in certain instances violate contractual confidentiality provisions with DEF's vendors.

Id. Accordingly, this information should be afforded confidential treatment by the Commission. *See* § 366.093(3)(d), F.S.

Furthermore, the Workpapers at issue relate to confidential competitively negotiated contractual data, such as pricing, contractual terms, and quantities of nuclear fuel, the disclosure of which would impair the efforts of the Company to negotiate the disposition of nuclear fuel assets on favorable terms. *See* § 366.093(3)(d), F.S.; Affidavit of Marcia Olivier at ¶ 6.

Upon receipt of this confidential information, strict procedures are established and followed to maintain the confidentiality of the information provided, including restricting access to only those persons who need the information to assist the Company. *See* Affidavit of Olivier at ¶ 8. At no time since receiving the information in question has the Company publicly disclosed that information. *See id.* The Company has treated and continues to treat the information at issue as confidential. *Id.*

CONCLUSION

The competitive, confidential pricing agreements, DEF employee names, contractor names, purchasers names, and banking information at issue in this request fits the statutory definition of proprietary confidential business information under Section 366.093, F.S., and Rule 25-22.006, F.A.C., and that information should be afforded confidential classification.

In support of this motion, DEF has enclosed the following:

- 1) Sealed Composite Exhibit A is a package containing an unredacted copy of all the documents for which DEF seeks confidential treatment. Composite Exhibit A is being submitted separately in a sealed envelope labeled “CONFIDENTIAL.” In the unredacted version, the information asserted to be confidential is highlighted in yellow.

2) Composite Exhibit B is a package containing two copies of redacted versions of the documents for which the Company requests confidential classification. The specific information for which confidential treatment is requested has been blocked out by opaque marker or other means.

3) Exhibit C is a table which identifies by page and line the information for which DEF seeks confidential classification and the specific statutory bases for seeking confidential treatment.

4) Exhibit D is an affidavit attesting to the confidential nature of information identified in this request.

WHEREFORE, for the foregoing reasons, DEF respectfully requests that this Seventh Request for Confidential Classification be granted. DEF requests that the information identified in Exhibit A be classified as “proprietary confidential business information” within the meaning of section 366.093(3), F.S., that the information remain confidential for a period of at least 18 months as provided in section 366.093(4) F.S., and that the information be returned as soon as it is no longer necessary for the Commission to conduct its business..

BEFORE ME, the undersigned authority duly authorized to administer oaths, personally appeared Marcia Olivier, who being first duly sworn, on oath deposes and says that:

1. My name is Marcia Olivier. I am over the age of 18 years old and I have been authorized by Duke Energy Florida (hereinafter "DEF" or the "Company") to give this affidavit in the above-styled proceeding on DEF's behalf and in support of DEF's Seventh Request for Confidential Classification. The facts attested to in my affidavit are based upon my personal knowledge.

2. I am the Director of Rates and Regulatory Planning for Florida. This section is responsible for overseeing rate cases, reporting actual and projected earnings surveillance results, and supporting state regulatory initiatives for DEF.

3. As the Director of Rates and Regulatory Planning, I am responsible, along with the other members of the section, for calculating and itemizing the DEF's total CR3 regulatory asset value consistent with the Revised and Restated Stipulation and Settlement Agreement ("RRSSA").

4. DEF is seeking confidential classification for portions of the Florida Public Service Commission Staff-Generated auditors' workpapers (the "Workpapers"). These documents contain contractual, financial, DEF employee, and vendor information, the disclosure of which would impair DEF's competitive business interests. A detailed description of the confidential information at issue is contained in confidential Exhibit A to DEF's Request and is outlined in DEF's Justification Matrix that is attached to the Request as Exhibit C. DEF is requesting confidential classification of these documents because they include confidential and proprietary contractual and financial information, and other information related to the Company's competitive business interest, the disclosure of which would compromise DEF's competitive business interests and in certain instances violate contractual confidentiality provisions with DEF's vendors.

5. The Company is requesting confidential classification of this information because the Workpapers contain proprietary and confidential financial information that would impair DEF's competitive business interests if publicly disclosed, including information concerning contractual and financial data, the disclosure of which would impair the Company's ability to contract on favorable terms and, in many cases, the information constitutes trade secrets of the Company and its contract partners. Specifically, portions of these documents contain confidential contractual data, including pricing agreements, payment information and other financial and contractual terms, the

release of which would impair DEF's competitive business interests. The disclosure of this information would compromise DEF's competitive business interests and in certain instances violate contractual confidentiality provisions with DEF's vendors.

6. Portions of the Workpapers contain competitive confidential business information of both DEF and third-party companies that contractually purchased nuclear fuel, such as the number of nuclear fuel assemblies and fuel rods, pricing and other contractual terms for the sale of nuclear fuel. DEF negotiates with potential nuclear fuel buyers to obtain competitive contracts to sell the CR3 nuclear fuel that in turn, provides economic value to DEF and its customers. In order to obtain such contracts, however, DEF must be able to assure companies purchasing nuclear fuel that sensitive business information, such as the pricing terms of their contracts, will be kept confidential. With respect to the information at issue in this request, DEF has kept confidential and has not publicly disclosed confidential contract terms such as pricing and similar competitive information. Absent such measures, purchasing companies would run the risk that sensitive business information that they provided in their contracts with DEF would be made available to the public and, as a result, end up in possession of potential competitors. Faced with that risk, persons or companies who otherwise would contract with DEF might decide not to do so if DEF did not keep those terms of their contracts confidential. Without DEF's measures to maintain the confidentiality of sensitive terms in contracts between DEF and purchasers of nuclear fuel, the Company's efforts to obtain a competitive nuclear fuel contracts could be undermined.

7. The confidential Workpapers at issue also contain personal employee information and personal contractor information that are considered sensitive business

information, the disclosure of which would violate individual employees' and contractors' rights to privacy and impair the Company's competitive business interests. Specifically, the confidential documents at issue contain employee names, coupled with reimbursement information (e.g., travel costs, materials, meal and lodging reimbursements), that if publicly disclosed would violate the employees' right to privacy. Moreover, disclosure of this information would impair DEF's competitive business interests by signaling to its employees (and those whom DEF may seek to employ) that DEF is unable to maintain the privacy of its employees. This could result in DEF being viewed as a less desirable place to work versus competitors for talented employees that can protect employee information, ultimately resulting in DEF either not being able to attract or retain qualified employees, or being forced to overcompensate such employees to the detriment of DEF and its customers.

8. With respect to the information at issue in this request, DEF has kept confidential and has not publicly disclosed such confidential information and agreements. Strict procedures are established and followed to maintain the confidentiality of the terms of the agreements and information provided, including restricting access to those persons who need the information to assist the Company, and restricting the number of, and access to the information and documents. The Company has treated and continues to treat the information and documents at issue as confidential.
