3 **MS. CORBARI:** Good morning, Commissioners.

4 Kelley Corbari for Commission staff.

5 Item 2 addresses Docket 150022, the initiation
6 of show cause proceedings against Wildwood Water Company
7 for failing to remit its regulatory assessment fees for
8 the years 2009 through 2014 totaling \$71,037.32, which
9 includes statutory penalty and interest through today,
10 and failing to timely file its annual reports for 2009
11 through 2013.

12 Wildwood has submitted a proposed settlement
13 agreement to resolve its apparent violations of
14 Commission statutes and rules. Staff is recommending
15 the Commission approve the proposed settlement. Staff
16 believes the proposed agreement to be in the public
17 interest and that it provides for the utility's future
18 compliance with Florida Statutes and Commission rules
19 and promotes administrative efficiency, avoiding the
20 time and expense of litigation. Staff is available for
21 any questions.

22 **CHAIRMAN GRAHAM:** Thank you, staff.

23 Commissioners, any questions of staff? I'll
24 entertain a motion.

25 **COMMISSIONER BRISÉ:** Move staff.

1 **COMMISSIONER EDGAR:** Second.

2 **CHAIRMAN GRAHAM:** It's been moved and
3 seconded, staff recommendation on Item No. 2. Any
4 further discussion? All in favor, say aye.

5 (Vote taken.)

6 Any opposed? By your action, you've approved
7 Item No. 2.
