Good afternoon, Ms. Watts,

We were first made aware of a complaint regarding the Sandalhaven WWTP on April 16, 2014. Robert Feldman of Charlotte County DOH called Keith Kleinmann and informed him of his findings from his inspection of the site the day prior (see attached DOH report). Keith sent me a brief email regarding the complaint and I performed an inspection that same day (see attached email). While I was on site for the inspection, Mr. Furman approached me and shared his concerns and asked to be kept informed of any DEP actions in regards to the Sandalhaven WWTP.

On May 2, 2014, a complaint from Veronica Stier was forwarded to my attention via Lina Cerquera of DEP's Office of Emergency Response (see attached email). I called Ms. Stier and let her know that we were already aware of possible issues with the Sandalhaven WWTP and would be sending the facility a Compliance Assistance Offer letter.

Our Compliance Assistance Offer letter was issued on May 5, 2014. Fiddler's Green brought this letter to the attention of the Lemon Bay Conservancy, who also reached out to me to express their concerns regarding the facility. Letters received from Lemon Bay are also attached.

In total, 3 complainants contacted our office to express concerns regarding the Sandalhaven WWTP. They were: Leroy Furman, President Fiddler's Green Condominium Association II, Inc (941) 697-9359

Veronica Stier Fiddler's Green resident (941) 214-8747

Percy Angelo, VP Lemon Bay Conservancy, Inc (941) 830-8922

The CAO issued on May 5, 2014 and the LFCO executed on October 8, 2014 were intended to address these complaints. Utilities Inc ultimately decided to connect the Sandalhaven WWTP to the City of Englewood. All flow was diverted on November 2, 2015 and the facility is currently being decommissioned. Upon receiving notification of the completion of the decommissioning, we will close our enforcement case.

Mr. Lawson:

As we discussed on the phone, Utilities Inc. of Sandalhaven (Sandalhaven) has a request for a rate increase with the Commission. Sandalhaven is a wastewater only utility in Charlotte County. The perc ponds have been unable to handle the demand from the customers, and wastewater was leaching out into the surrounding area. After receiving complaints from residents near the plant, or from the county health department (I'm not certain of the exact DEP contact history with this system). DEP investigated, found the ponds were failing and entered into a Consent Order with Sandalhaven to reroute the wastewater to another treatment facility (Sandalhaven has a contract with Englewood Water District for treatment) and decommission the WWTP.

wastewater complaint, I also had septic inspection less than mile from site. I contacted Complainant, met him at 1:12 PM, at the percolation pond for Utilities Inc, at 6811

Placida Rd. He showed me the swale alongside the percolation pond with several inches of water, covered by a green mat of growth, similar to that in the pond. He states it has been like that since at least September, 2013.

The water flows down the ditch, thru a culvert alongside several apartment buildings towards Lemon Bay Creek. The creek leads to Lemon Bay and Lemon Lake. The creek is also the breeding ground for tarpon hatchlings. The complaint appears to be valid. I took several photos of the ditch, the pond, the ditch at entrance to the creek. The complainant has taped off the area with caution tape to keep people from walking thru the water. I also met with Glen Spears, maintenance man for the complex. Another area of concern is the ditch between Townhomes 3 & 4 as it is wet, spongy, leads also to the main swale and into the creek. I took some photos at this site. Complainant then showed me the wet area on the left side of same percolation pond. This area was saturated with signs of overflow onto the parking lot and dumpster area. He has taped off this area as well. I took photos here. At times, complainant says area is so deep in water, tenants are unable to dump garbage without walking thru the standing water. The Utility used to have contract to provide 100,000 gpd of treated wastewater to the golf couse adjacent to property. The agreement is over and the Utility percolates the water into the ground. He says Sanders Labs took samples and has counts of 400 and 300 cfu. I have not received a copy of this report. I informed complainant of our DEP agency agreement and told him I will be referring complaint, rf

I informed him of the findings from yesterday, I provided him with complainants name, number, fax number. Re:

Lemon Bay Conservancy is a land conservancy serving Lemon Bay and Charlotte Harbor. We own the Wildflower Preserve, a nature preserve located on Gasparilla Pines Boulevard in Englewood, which is bordered on the south by the Sandalhaven WWTP and various condo associations including Fiddlers' Green II (FG II).

FG II has called our attention to a letter sent by you to Patrick C. Flynn of Utilities, Inc. of Sandalhaven regarding a compliance inspection of the Sandalhaven WWTP showing a violation of effluent disposal requirements in that operation of the "facility percolation ponds has created, via seepage and excessive groundwater mounding, an unauthorized offsite discharge to adjacent properties, adjacent stormwater retention ponds, and potentially to nearby surface waters related to Lemon Creek and Lemon Bay."

Apparently percolation ponds at the WWTP are being operated at a rate of 79,000 gallons per day, instead of 45,000 gallons per day.

We know our neighbors at FG II are extremely concerned, as are we. The impacted "nearby surface waters related to Lemon Creek and Lemon Bay" are located to a large extent on our Wildflower Preserve property. Among other potential impacts our brackish Wildflower ponds which are connected to Lemon Creek have been found to function as a nursery area for juvenile tarpon. The ponds and tarpon are currently being studied by a collaboration of various experts, including Mote Marine, the first such juvenile tarpon study anywhere.

The concern is especially strong in light of the coming rainy season which increases the rate of both overland and subsurface flow of WWTP effluent with resulting impact to our tarpon nursery ponds. In addition to the risk to neighboring residents, the potential damage to the juvenile tarpon affects the area wildlife communities as well as the economic resource represented by the tarpon fishery: over \$110 million in Charlotte Harbor alone based on a study by Dr. Aaron Adams of Mote.

We ask that you keep us informed of your findings regarding this noncompliance and that you press to see that the situation is resolved immediately. We know our FG II neighbors feel the same way. We believe, for example, that in the past Sandalhaven had an agreement to discharge flow to the Englewood Water District and wonder if that couldn't be a solution to the problem.

Thank you for your efforts and we look forward to hearing back from you.
