11 *Florida Administrative Code*. These rules implement the
12 Commission's jurisdiction to regulate and supervise
13 public utilities rules and regulations, rate schedules
14 and tariffs, and the Commission's power over municipals
15 and cooperatives to prescribe a rate structure. The
16 amendments clarify and simplify the rules and delete
17 unnecessary and redundant rule provisions. Staff is
18 available for questions.
