Cordia Communication Corp.'s outstanding RAFs in docket number 110326-TX

due to bankruptcy.

On March 15, 2012, the Commission issued Order No. PSC-12-0124-PAA-TX, granting Cordia Communication Corp.'s (Cordia) request for cancellation of its Certificate of Authority because of bankruptcy. At the time of the request, Cordia had outstanding Regulatory Assessment Fees (RAFs) of \$600.

In Order No. PSC-12-0124-PAA-TX, the Commission also ordered that the outstanding RAFs shall not be sent to the Department of Financial Services for collection, and that the Division of Administrative Services shall instead request permission to write-off the uncollectible amount. Pursuant to 11 USCS § 362 of the US Bankruptcy Code, Cordia Communication Corp.'s bankruptcy filing acts as a stay to enforcing any judgment against Cordia Communication Corp.

Therefore, staff requests that the Division of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write-off the uncollectible penalty and Regulator Assessment Fees for Cordia Communication Corp.
