The Florida Public Service Commission will consider at its January 5, 2016 Commission Conference, Docket No. 150251-GU, Application by for Authorization to Issue Common Stock, Preferred Stock and Secured and/or Unsecured Debt, and to Enter into Agreements for Interest Rate Swap Products, Equity Products and Other Financial Derivatives, and to Exceed Limitation Placed on Short-Term Borrowings in 2016 by Chesapeake Utilities Corporation (Chesapeake or Company).
