3 **MS. PAGE:** Good morning, Commissioners.

4 Pamela Page with the Office of General Counsel.

5 In Item 2 staff is recommending that the
6 Commission propose the amendment of Rules 25-6.093,
7 25-6.097, 25-6.100, 25-7.079, 25-7.083, and 25-7.085,
8 *Florida Administrative Code*. The rules implement recent
9 amendments to Section 366.05, *Florida Statutes*, which
10 impose new requirements on electric and gas utilities
11 regarding customer billing, customer deposits, and
12 customer information.

13 Section 366.95, *Florida Statutes*, requires
14 billing notices to customers for electric utilities that
15 have obtained a financing order for nuclear assets and
16 have caused nuclear asset-recovery bonds to be issued.
17 The rules have been clarified and updated, and obsolete
18 or redundant language has been removed. Staff is
19 available for any questions.

20 **CHAIRMAN GRAHAM:** Commissioners, any questions
21 of staff? Seeing none, I'll entertain a motion.

23 **COMMISSIONER BROWN:** Mr. Chairman, this is in
24 conformance with the amendments to 366, and with that I
