Good afternoon, Matt.

Staff has received the petition from Duke and OUC requesting approval of a term extension to the territorial agreement in Orange County (Docket No. 160025-EU). Both the instant petition and the proposed amendment requesting the term extension refer to the "Current Agreement" approved in 2007 as being applicable to Orange and Osceola Counties.

In conducting preliminary research of the historical record supporting the Current Agreement, staff could not locate any references to territory within Osceola County. If you would, please clarify why the instant petition and the proposed amendment include Osceola County in the discussion of areas covered under the Current

Agreement for which the proposed term extension is being sought. This additional clarification would be most helpful to staff in evaluating the petition.
