

## NOTICE OF COMMISSION MEETING UNDOCKETED PAGE 5

The conduct of Commissioners is governed by the standards set forth in Chapter 350 and part III of Chapter 112, Florida Statutes (F.S.). The standards presented in Chapter 350 for Commissioners exceed the standards imposed on Commission employees by Chapter 112, F.S. In event of a conflict between Section 350.041, F.S., and part III of Chapter 112, F.S., the more restrictive provision applies.

#### **CHAPTER 350, FLORIDA STATUTES**

Prohibition Against the Acceptance of Gifts by Commissioners, Section 350.041(2)(a) and (d), F.S.

A Commissioner may not accept anything from:

- · any public utility regulated by the Commission;
- any business entity that directly or indirectly owns or controls a public utility regulated by the Commission;
- any business entity that is directly or indirectly an affiliate or subsidiary of any public utility regulated by the Commission;
- a party to a proceeding currently pending before the Commission

If the Commission on Ethics ("COE") determines that a party to a proceeding currently pending before the Commission gave or provided a prohibited gift to a Commissioner, the person may not appear before the Commission or otherwise represent anyone before the Commission for a period of 2 years.

Prohibition Against Solicitation of Gifts by Commissioners, Section 350.041(2)(i) F.S.

A Commissioner may not directly or indirectly, through staff or other means, solicit anything of value from:

- · any public utility regulation by the Commission;
- any business entity that, whether directly or indirectly, is an affiliate or subsidiary of any public utility regulated by the Commission; or
- any party appearing in a proceeding considered by the Commission in the last 2 years.

#### **CHAPTER 112, FLORIDA STATUTES**

Definition of gifts under Ch. 112, F.S.: A gift is anything of value accepted or given, directly or indirectly, for which nothing of equal or greater value is given in return.

A gift includes:

- · real property or its use;
- · tangible or intangible personal property or its use;
- a preferential rate or terms on a debt, loan, goods, or services which rate is below the customary rate and is not available to similarly situated persons:
- · forgiveness of an indebtedness;
- transportation (other than that provided to a public officer or employee by a defined agency in relation to officially sponsored governmental business), lodging, or parking;
- food or beverage,
- · membership dues;
- entrance fees, admission fees, or tickets to events, performances, or facilities; however, the value of a gift of an admission ticket does not include that portion of the cost which represents a charitable contribution, if the admission ticket is provided by the charitable organization:
- · plants, flowers, or floral arrangements;
- services provided by persons pursuant to a professional license or certificate:
- other personal services for which a fee is normally charged by the person providing the services; and
- · any other similar service or thing having an attributable value.

You (and your employees, spouses, and children) are prohibited from soliciting and/or accepting compensation, payment, or a thing of value that you know, or with the exercise of reasonable care should have known, was given with the expectation of influencing your vote or other action in your official capacity.

- You may not knowingly accept, directly or indirectly, gifts having a value in excess of \$100 from members of the prohibited class.
- "Prohibited class" means a lobbyist or the partner, firm, employer, or principal of a lobbyist; or a political committee. This also includes any vendor with which the Commission does business pursuant to Chapter 120, F.S.

Prohibition Against Acceptance of Honoraria for "Reporting Individuals" and "Procurement Employees" (RIPE)

<u>Definition of "Honorarium," Section 112.3149(1Xa), F.S.</u> "Honorarium" means a payment of money or anything of value, directly or indirectly, to a reporting individual or procurement employee, or to any other person on his or her behalf, as consideration for:

- A speech, address, oration, or other oral presentation by the reporting individual or procurement employee, regardless of whether presented in person, recorded, or broadcast over the media; or
- A writing by the reporting individual or procurement employee, other than a book, which has been or is intended to be published.

"Honorarium" Does NOT Include:

- Any ordinary payment or salary received pursuant to one's public duties;
- A campaign contribution reported pursuant to Chapter 106, F.S.: or
- The payment or provision of actual and reasonable transportation, lodging, and food, and beverage expenses related to an honorarium event, including any event or meeting registration fee.

Honorarium Solicitation Prohibited, Section 112.3149(2), F.S.: A RIPE is prohibited from soliciting an honorarium which is related to his or her public office or duties.

Honorarium Acceptance Prohibitions, Section 112.3149(3), F.S.: A RIPE is prohibited from knowingly accepting an honorarium from the followings:

- A political committee or committee of continuous existence, as defined in Section 106.011, F.S.;
- A lobbyist as defined in Section 112.3149(1)(d), F.S.; or
- · The employer, principal, partner, or firm of a lobbyist.
