The date was Feb 8th. There were 19 complaints of cloudy water Here are some of the quotes off our internal website:

Is anyone else having an issue with their drinking water? Just noticed this morning water is cloudy coming out of the tap.

A tad cloudy . I always drink bottled water . The tap water tastes stronger then bottled water.

Yes noticed it yesterday!

We have same issue in Ocean Breezeon Whaler Dr

we have only used bottled water. not even my dog will drink it

Just spoke to Aquarina Utilities who gave me the number of a guy named Kevin who is handling Osprey Villas Ct water issue at 212. He said it's only air. It should be safe to drink. He's got someone working on it now.

I have noticed cloudy since the weekend. Blue Heron.

The water company has spent over a week trying to repair a line on Osprey Villas Court. On Saturday, I notified them of another leak at our driveway. My feeling is the water company is not equipped to handle our aging system. I've heard many excuses but few solutions. Not happy!!

"This is exactly the problem, the unscrupulous, corrupt, and unlawful couple who own and operate Aquarina Utilities, Inc. did the usual again... When there is an equipment failure whether it be a water line integrity issue, a failed pump, inadequate levels of water volume for fire suppression, or in this case, a failed Reverse Osmosis system: they never follow state law which requires that they inform us immediately to refrain from drinking the water and taking necessary precautions such as boiling water for consumption. They wait for someone in our community to notice a problem, then they assign blame!! "

Please help us to ensure competent water caretakers to provide safe water. These owners of our utilities put us off and now on the 10th March want to raise our rates for inferior service/product
