By Order No. PSC-16-0107-PAA-WU, in Docket No. 150230-WU, issued March 15, 2016, the Florida Public Service Commission (Commission) approved the application of Utilities, Inc. of Florida, as successor to Sanlando Utilities Corporation, (Utility) to provide potable water service to 116 lots within the Myrtle Lake Hills subdivision in Seminole County.
