

To Whom it May Concern,

Please accept our sincerest apologies for the delay in response to your inquiries. As a way of explanation, not excuse, we would like to divulge that we have had a serious breakdown with regards to matters concerning our post. These problems have occurred at the postal level and at our own offices. We frequently send mail which is not received or not received in a timely manner. We have complained several times to the Post Master at our local branch. In April of this year I spoke with Ms. Toni Earnhart at Florida Public Service Commission and she advised that our filing was past due, that it had not been received. We immediately sent her the filing itself but the payment had to be referenced with the bank as the payment had been remitted in January. When we determined that payment had not been processed we sent our payment, certified return receipt, to Ms. Earnhart. Our Check was cashed on May 17th. It has come to our attention that subsequent to the receipt our payment, on May 19th, letters were sent to our PO Box and were sent back to the Florida Public Service Commission unclaimed. These are the failures that occurred at the postal level, we frequently fail to receive items because we do not receive any notice that anything is waiting to be claimed.

Subsequent to this information sent to us by Mr. Jeff Bates was sent to our registered address, our corporate office, and this information did not make it to our physical office where our accounting and operations are managed. In an effort to ensure that this NEVER happens again I have updated our information on the renewal application to include both our PO Box and physical mailing address along with my direct email. I cannot apologize enough for these terrible breakdowns in communication.

Should anyone need to contact me for any reason please feel free to do so. I am including all of my contact information, including personal contact information as I will be out of the office from June 28th – July 5th.


