4 **MS. OLLILA:** Good morning, Commissioners. Sue
5 Ollila for staff. Item 9 is Duke Energy's petition for
6 approval of modifications to its standby generation
7 program tariff and program participation standards. It
8 is a voluntary program, but effective May 1 there are
9 revised EPA regulations. Duke's proposed tariff --
10 under the proposed tariff, customers with equipment that
11 is not compliant with the new EPA standards and who wish
12 to remain standby generators will have until the end of
13 this year to be -- to upgrade their equipment. There
14 have been no customer contacts, and staff recommends
15 approval.

17 Commissioners, any comments, questions or
18 thoughts?

20 **COMMISSIONER GRAHAM:** Yes, thank you, Madam
