THE MAJORITY OF US ARE NOT GOING TO BE ABLE TO TAKE ON THIS INCREASE WITHOUT ELIMINATING OTHER NECESSARY EXPENDITURES.

USE FPL EARNINGS TO MODERNIZE AND UPGRADE. DELAY THE SOLAR CENTERS FOR THE NEXT FEW YEARS. AS FOR OKEECHOBEE, DELAY THE COMPLETION OF THIS PROJECT UNTIL 2025. MEANWHILE USE MORE EARNINGS TO PUT ASIDE FUNDS FOR SOLAR CENTERS AND OKECHOBBEE AND PAY LESS DIVIDENDS TO STOCKHOLDERS.
