

I'm writing to speak out against Florida Power & Light's proposed increase in rates. FPL's request equals a 23 percent base rate increase for all residential ratepayers (this is a charge increase even before you flip on a switch,) and would allow an unprecedented return on equity (shareholder profit) of 11.5 to 12.5 percent. FPL's request equates to a \$1.34 billion increase in base rates. Know these two facts about FPL's request:

- 1. \$960 million of FPL's rate increase will go into FPL investors' pockets. None of those funds will go to service enhancements, disaster preparedness, or energy innovation.
- 2. According to their own filing with the PSC, FPL is on target to make \$1.6B in profit in 2017 without the requested rate increase.

Given these startling facts, I find it preposterous this money grubbing utility company would ask for such a large increase when many of their customers cannot even afford their medications. And to make matters worse, these customers have no other choice of electricity service available to them! FPL executives not only should be denied their request, they should be imprisoned for extortion!
