I have been a Florida resident since 1962 and now 70 years of age and retired on a fixed income with no future Cost Of Living (COL) increases to look forward to in any of my pensions. I retired from the United States Air Force on 1 April 1989 after completing 21 years in the military and have a 10% service connected disability. I took a position at the Defense Commissary Agency (DECA) after retiring from the military and retired from DECA after fifteen years of Civil Service at 59 1/2 years of age. Everything is going up except for our pensions and social security. Property taxes are about to increase dramatically here in the County of Brevard where four out of five county commissioners have voted to remove the 3% tax cap that has protected us from runaway taxation that is about to hit hard this year or the next and beyond. I own my home outright at the present time but it is in need of renovations that will require me to mortgage my home once again to make those badly needed repairs. I am not alone here because many of my fellow senior citizens are facing the same situation with all of the increases in our power bills and property taxes which, in fact reduce our quality of life in the final years of our lives. Please look at all of the innovative "fees" and "charges" on our electric bills right now - "Customer Charge" - \$7.87; "Storm Charge" - \$4.05; "Franchise charge" - \$14.02; "Gross Receipts Tax" - \$5.84; "Fuel Charge" - \$65.74 (these were on my 21 July 2016 statement. Furthermore, FPL has reduced the amount I used to get from my "On Call Credit" from \$9.50 per month to \$4.50 per month which is just like increasing my monthly bills by \$5.00 a month forever. I think all of the above must be taken into consideration before making a decision in favor of another rate increase because we are already being gouged as it is. I have done everything I can to reduce my energy consumption here at the house to include changing all of my incandescent and CFL bulbs to LEDs. I hang most of my clothing up to dry rather than to use the dryer. I increase my thermostat temp when we leave the house, etc., etc. I've done my part but no matter how I try I cannot find ways to keep my power bills from going up as the Florida summers seem to get hotter and hotter with each passing year. We all need some kind of a break here and it is up to you to prevent even more corporate greed than we already have at present.
