Dear Representative Mayfield:

Thank you for your letter, dated September 22, 2016, which has been placed in Docket Correspondence, Consumers and their Representatives, in Docket No. 160049-EU, *In re: Petition by the Town of Indian River Shores for Modification of Territorial Order Based on Changed Legal Circumstances Emanating from Article VIII, Section 2(c) of the Florida Constitution.* As I stated at the Agenda Conference on September 13, 2016 (September Agenda Conference), I have a deep appreciation for your passion and interest in resolving this long standing matter facing your constituents.

I'd like to lay out the present procedural posture of this docket for clarification. As you are aware, the Florida Public Service Commission (Commission) voted to deny the Town of Indian River Shores' Petition for Modification of Territorial Order Based on Changed Legal Circumstances at its September Agenda Conference. Since this decision is preliminary in nature, it will be memorialized in a Notice of Proposed Agency Action (PAA) Order, which should be issued within 20 days of the Commission's vote. Any person whose substantial interests are affected by this PAA Order may file a petition for hearing, as provided by Sections 120.569 and 120.57, F.S., within 21 days of issuance of the Order. In the absence of such a petition, the PAA Order shall become final and effective upon the issuance of a Consummating Order.

Please note that since the September Agenda Conference, I have directed our Commission staff to reach out to your staff to serve as a resource for supplying information and assistance to you in achieving your legislative objectives. I have also asked our Executive Director to reach out to you to coordinate an in-person meeting with you and Commission staff for further assistance. Please contact me directly if you have any questions or would like to discuss this further.
