

By Order No. PSC-16-0370-PAA-WS, in Docket No. 150149-WS, issued September 14, 2016, the Florida Public Service Commission (Commission) approved an increase in water rates in Glades and Highlands Counties, for Silver Lake Utilities, Inc. The old charges shall be prorated based on the number of days in the billing cycle before the effective date of the new rates. The new charges shall be prorated based on the number of days in the billing cycle on or after the effective date of the new rates.
