2 **CHAIRMAN BROWN:** Moving on to Item 9. Good
3 morning.

4 **MS. OLLILA:** Good morning, Commissioners. Sue
5 Ollila for staff.

6 Item 9 is Peoples Gas System's amended
7 petition for approval of tariff modifications to rider
8 NCTS, the firm delivery and operational balancing
9 agreement and the negative imbalance cash-out prices.
10 Two pool managers provided comments concerning Peoples'
11 original petition. Subsequently, a noticed informal
12 meeting was held with representatives from Peoples'
13 staff, the Office of Public Counsel, and pool managers.
14 The amended petition was filed in response to the
15 discussion at the informal meeting.

16 The proposed modifications in the amended
17 petition include requiring pool managers to pay their
18 portion of the cost of peaking and future growth of
19 streamed capacity. Also included is an increase in the
20 prices paid by pool managers when their customer pool
21 consumes more gas than is scheduled to be delivered by
22 the pool manager, and the proposed modifications allow
23 pool managers to increase the quantity of upstream
24 capacity released during the month.

25 Company representatives are here to answer any

1 questions you might have. Staff recommends approval.

2 **CHAIRMAN BROWN:** Thank you, Sue.

3 Commissioners, any questions? Can I get a
4 motion?

5 **COMMISSIONER EDGAR:** Move staff.

6 **COMMISSIONER GRAHAM:** Second.
