On October 11, 2016 AT&T informed you that pursuant to Section 4.5.2 of AT&T Florida's Self Effectuating Enforcement Mechanisms Administration Plan ("SEEM Plan"), AT&T Florida declared a force majeure event effective October 6, 2016 due to Hurricane Matthew. We are pleased to inform you that as of October 18, 2016, AT&T Florida has lifted its force majeure declaration associated with Provisioning, Maintenance and Repair, and Trunk Group performance in the designated wire centers.
