3 storm hardening.

4 Good morning, Ms. Buys.

5 **MR. BUYS:** Good morning, Commissioners. I'm
6 Penelope Buys with Commission staff.

7 Item 6 addresses the petition seeking approval
8 of the 2016 through 2018 storm hardening plans filed
9 pursuant to Rule 25-6.0342 F.A.C. in Dockets No. 160105,
10 160106, 160107, and 106108 by Tampa Electric Company;
11 Florida Public Utilities Company; Duke Energy Florida,
12 LLC; and Gulf Power Company.

13 The updated plans are largely a continuation
14 of the current Commission-approved plans for each of the
15 four utilities. Staff recommends approval of the
16 updated storm hardening plans and notes that approval of
17 the plans does not mean approval of the cost -- for cost
18 recovery.

19 No objections to the petitions were filed with
20 the Commission and the time for doing so has expired.
21 In addition, there were no customer comments filed in
22 the dockets. Parties are present to answer questions
23 the Commission may have on this item. Staff is
24 available for questions.

1 your work on this.
