A variation on the FPL deal could be for the PSC to require FPL to spend more on various capital investments and operational policies that ultimately give the rate payers more for their money, thereby driving down the FPL ROE closer to the national average: e.g.,

More generous time of use rates and service interruption monthly credits optionally available to customers of all stripes.

Expand and accelerate the hardening and updating of their primary and secondary transmission and distribution infrastructure, lessening the severity and frequency of service interruptions (a real additional cost when they occur to users). As part of this approach, on a jurisdiction by jurisdiction basis when a system hardening is planned, offer to finance to the jurisdiction the incremental difference of undergrounding vs. aerial features to an extent selected by the respective jurisdiction from an array of options offered by FPL.

FPL is globally unique in that its core service area is contiguous to one of the most dependable, consistent and environmentally-benign "clean" power sources in the world: the Gulf Stream. The PSC needs to hunker down on FPL to use some of its ROE to develop a detailed and monitored (by PSC) program to bring the Gulf Stream on line.

FPL has shown some progressive and creative moxie in its operations in recent years (smart meters for most users and transmission/distribution field SCADA), but needs to do a whole lot more. The PSC has a statutory responsibility to make this "whole lot more" happen.
